




They don't want you to learn who was the real SHAKESPEARE

But here's our optimistic view: once the traditionalists take, for themselves, a full, open-minded look at the evidence for the first time (...as we in the U.S.A. have lately been urging everyone to do pertaining to **elections**...), and then once they do accept Edward de Vere, 17th Earl of Oxford, as the true author, this is going to re-energize worldwide excitement about Shakespeare to be even far greater than ever before!

We anticipate...

...the new excitement is going to include university Shakespeare study programs expanding to incorporate the triumphs and travails of Oxford himself, and all the intrigues and rivalries and colorful personalities and portentous dramas of the Elizabethan royal court he frequented, and all the turbulent ongoing events of that historical period and how these intertwined to influence and shape the plays and other works.

This will enhance the dazzling Shakespearean canon for all ages to come.

There will be so much more to study, analyze, and newly-research than there already has been until now!

This will reverse the recent tendency of academic Shakespeare departments to downsize – they'll be upsizing instead.



Tour buses will still visit Stratford-upon-Avon. Then they'll continue to places such as Castle Hedingham and Hackney where the actual author himself lived: Edward de Vere, 17th Earl of Oxford.

In other words...the Shakespeare tourist industry is going to get a lot bigger, not smaller.

Our objective is to convince the traditionalists of all this and win them over. We believe that very soon they'll all realize this is going to make Shakespeare far "better, not worse". Oxford as the "secret identity" is going to add a whole new dimension of glamor, mystique, and political intrigue to Shakespeare!

And then in the preface poem, Jonson's praise of the "Sweet Swan of Avon", seeming to point to Stratford-upon-Avon, appears to have been a sly misdirection...because "Avon" had also traditionally referred to Hampton Court Palace on the Thames, the royal venue where many of Oxford's plays received their first performances...not in public theaters such as the Globe.
